

Use Tax Update (Spec 5193)

Date Released: Nov 2016

Modules: Navigator Order Management, Navigator Invoicing, Classification Code File - Ship Vias (FIL 19), Cost Drivers File Maintenance (CDR 1).

Description: Allows businesses that have to pay Use Tax (primarily installers) to see how Use Tax is going to affect their GP\$/margin for the order. This also allows Use Taxes to be used in commission calculations.

Reason for Change: Provides a way within order entry and invoicing to ensure that any manual pricing override does not push an order's margin to unacceptable levels. Furthermore, order lines for items, usually labor items, that use ship vias not configured to calculate use tax are omitted.

Restrictions:

- This is a NAV only enhancement.
- Running reports prior to invoicing to show Use Tax. The calculated and displayed Use Tax and affected GP\$/GP% values are display only.
- Invoice inquiry prior to NJ will not show use tax.
- Misc (F6) Lines are excluded from use tax calculation. Cost drivers do not look at F6 lines and thus these lines will not be included in any use tax calculation.

Associated Files:

- Sales Tax Report for Non-Taxed Items - Use Tax (RSA 12) - This feature allows you to run tax accrual reports for some states and items where the tax is calculated on the cost of the item. For example, use this report when samples are sent to customers at no charge or samples are used in your showroom (and billed to an intercompany account at no charge) and there is a tax liability. This is also referred to as "Use Tax". This program looks for items that (a) were sold at "no charge", (b) have special tax codes in the Item File, and (c) other items that were not charged tax.
- "X By Y" Reports With Cost Drivers - The X by Y Reports portion of the Cost Drivers menu includes report options that you can run with all or selected Cost Driver categories.

Set-up

Cost Drivers (CDR 1)

Cost drivers are used to calculate the Use Tax for Invoicing.

The setting **Calculate Use Tax for this Cost Driver** has been added.

Note: Setting Default is N.

If activated, the values in the bottom section of the page are not needed. The system uses the following hierarchy to determine what the % rate for the cost driver will be:

- Look at the Tax by Zip Code table for the shipto zip code.
- Look at the Billto file for state/other tax codes.
- Look at the county file for the Billto.
- No tax codes found, no use tax is charged.

Note: Cost Drivers are assigned via the F9 - Assign Cost Driver function. A series screens present several parameters for relating Cost Drivers to invoices based on "include/omit" parameters.

Ship Vias

Ship vias are used to calculate Use Tax in Order Management.

The setting **Show Estimated Use Tax for this Ship Via** is defaulted to “N”.

If the setting is set to “Y”, and the user is able to see costs, the Estimated Use Tax appears on Navigator and Green Screen Orders.

Use Tax in Navigator Order Management

If the ShipVia used is flagged to show estimated use tax and a cost driver is assigned that also calculates use tax, the use tax is calculated by multiplying the **Extended Cost** by the tax rate established in the Tax by Zip Code table for the account.
